Dual Purpose Expenses – must be prescribed by a licensed medical practitioner in treatment of a specific medical condition:

- Acne treatment (Retin A) – in treatment of a specific medical condition, such as acne vulgaris
- Adhesive or Elastic Bandages
- Dietary and/or herbal supplements
- Fiber supplements in limited circumstances
- Foot Spa
- Glucosamine/Chondroitin for arthritis or other medical condition
- Herbs
- Hormone therapy for menopause symptom treatments, such as hot flashes, night sweats, etc.
- Lactose intolerance treatments
- Massage therapy for Medical purposes
- Minerals
- Orthopedic shoes and inserts (for orthopedic shoes, reimbursement only for additional cost over non-orthopedic shoes)
- Prenatal vitamins
- St John's Wort for depression
- Sunscreen
- Vitamins
- Weight-Loss drugs in treatment of a specific disease (including obesity)
